

24-Day Challenge and Beyond Hawaii Trip Contest Rules

- The sweepstakes is open to AdvoCare Independent Distributors who are legal residents of the 50 United States and the District of Columbia who are 18 years of age or older.
- Only entrants logging onto the internet from within the 50 United States and District of Columbia are eligible to enter the sweepstakes.
- Sweepstakes only available to AdvoCare Independent Distributors who purchase a 24-Day Challenge and Beyond bundle on Jan. 1, 2013 and do not qualify for the Hawaii Hanalei Bay Incentive trip.

How to enter:

- Purchase the new 24-Day Challenge and Beyond bundle between 9 a.m. and 11:59 p.m. Central Time on Tuesday, Jan. 1, 2013 to be entered into a drawing for a Distributor and guest to have a chance to join us in Hawaii during the Hanalei Bay Incentive Trip May 14-18.
